1. Position title:

Designated associate professor or lecturer

(Note: This is a non-teaching, research-only faculty appointment)

2. Number of positions:

One position

3. Contract term:

Until 31 March, 2022

4. Content of duties:

- (1) Conduct research in the field of cultural heritage and textual studies and facilitate international scholarly exchange through the Nagoya University Graduate School of Humanities Research Center for Cultural Heritage and Texts (CHT), with the aim of internationalizing research and education at our school.
- (2) Other administrative duties, as deemed necessary.

5. Qualifications:

- (1) Applicants should have a substantial record of research and teaching at an institution of higher learning, either in Japan or abroad.
- (2) Applicants must have a Ph.D. in hand at time of appointment.
- (3) Applicants are expected to have an outstanding publication record in the field of premodern Japanese Buddhism or comparative studies of

premodern Chinese and Japanese Buddhism (focusing on literary or visual arts, history of exchange, or religious heritage).

- (4) Applicants must have citizenship in a country other than Japan. And applicants must have sufficient Japanese language skills to perform above duties.
